## Monthly Insurance Assessment and Licensing Committee (IALC) Application Review

In July 2025, seven insurance applications were reviewed, comprising of six new applications and one carried forward application. Of the seven, four applications were approved, two were deferred and one was deemed insufficient for review.

The registration of approved insurance entities occurs after the IALC application process has concluded. Therefore, the IALC approval and the registration approval may be rendered in different periods.
