PATI Request 2022 - 2

In response to your recent PATI request referenced above, in relation to the Bermuda Tourism Authority's visitor services centre on Front Street, I can provide the following information:

- 1. The initial budget for the construction was \$825,000. This excluded the acquisition of the containers and the Elevator, and work in relation to disability access.
- 2. Total cost in relation to the above were \$952,772. The additional costs related to the strengthening of the structure to meet Bermuda code. Namely:
 - a. Costs in relation to pilings for the foundations; and
 - b. New glazing as original Plexiglass solution not sufficiently wind resistant; and
 - c. Additional bracing for the windows noted above; and
 - d. Additional waterproofing and sealing.
- 3. Financial position. I have attached an extract of the approved accounts for the BVSC for the years 2018 2020. The account for 2021 should be available shortly. Please not that this includes the three Visitors Services Centre Dockyard, Hamilton and St George.
