

Ministry of National Security December 2nd Settlement

15th January 2019

Mr. Speaker, I rise today to provide clarity around recent happenings regarding the unfortunate events of December 2nd, 2016. Honourable Members will recall that date as the climax of ongoing protests of the One Bermuda Alliance's - then the Government – airport redevelopment plan.

Mr. Speaker, by all accounts, December 2nd, 2016 was a bad day for Bermuda. Several officers were injured, 14 members of the public were charged with offences, and 27 individuals raised complaints against the conduct of police with the Police Complaints Association. For those of us who witnessed the events first-hand, or through various media sources after the fact, the day is remembered as an unsightly blemish on Bermuda's normally peaceful reputation.

Mr. Speaker, Honourable Members will be aware that Government House commissioned a review by the National Police Coordination Centre (NPoCC) of the events of the day. That report highlighted twenty-six oversights in the planning and communication of the BPS policing plan to control the crowd on the day.

Similarly, Mr. Speaker, following the receipt of twenty-seven individual complaints, the Police Complaints Association (PCA) issued a report on its findings of the conduct of Bermuda Police Service (BPS) Officers on

the day. While the report found "no instances of misconduct that could be attributed to Officers at the Parliamentary grounds", the report did find that mistakes at the senior levels of the BPS did have a negative effect on the outcome of the day.

Mr. Speaker, I believe that the BPS has acknowledged their opportunities for service improvement. During my time as Minister of National Security, I have worked with the BPS to ensure that we have looked at each one of the identified failings and put a plan in place to rectify the shortcomings. I also believe that the protesters who were present that day are cognizant of the lasting effect the day's events have had on the community. Therefore Mr. Speaker, I do not intend to spend much time here today replaying the events of December 2nd, in order to assign blame to one segment or another.

Rather, Mr. Speaker, I would like to take some time to offer clarity and transparency on the Ministry of National Security's decision to use a progratia payment for full and final settlement with the 27 individuals who had their complaints turned down by the PCA. This decision was not taken lightly. The Government spent a lengthy period considering a number of social and financial factors. Ultimately, the decision to settle at this juncture was based on financial prudence.

Mr. Speaker, the Government was aware that the 27 individuals were not prepared to accept the PCA's decision to dismiss the complaints as final. In fact, these individuals intended to bring the matter for judicial review. Honourable Members will be aware that the PCA is appointed by His Excellency, the Governor, with the Ministry of National Security having administrative and financial responsibility. This means that the Ministry of National Security would be responsible for the cost of legal representation for the PCA.

Further, Mr. Speaker, the Ministry of National Security has administrative and financial responsibility for the BPS. This would have



been another significant cost for the Ministry as the fees associated with legal counsel for each officer would need to be funded by the Ministry. When considering the public purse, and faced with the reality of at least twenty-six shortcomings, as identified by the NPoCC report, by the police on the day, the Ministry could not support the likely insurmountable legal cost of an estimated nine month matter in the Supreme Court.

Mr. Speaker, the total \$225,000.00 pro gratia payment to these individuals represents one of many steps that this Government intends to take in order to bring closure to the events of December 2nd, 2016. There is currently a bi-partisan sub-committee that has been tasked with reviewing the
