<b>Wednesday February 5th</b>	Inmate [redacted] was locked down for 3 days for possession of unauthorized metal object. A call from the aunt of Rem. [redacted] was received informing him that his grandfather passed [redacted]. He appeared to be in good spirits.
<b>Thursday February 6th</b>	PORC escort; [redacted] went out to PORC to continue cleaning. Inmate [redacted] was seen by the Parole Board and granted parole. Waiting on EMD. A special search was conducted on inmate [redacted] in E2 cell 20. One cell phone was confiscated from under his desk. He was placed on charge.
<b>Friday February 7th</b>	PORC escort; [redacted] went out to PORC to continue cleaning. Medical Escort: [redacted] and [redacted] i/c [redacted] was escorted to KEMH for a medical assessment.
<b>Sunday February 9th</b>	Imp. [redacted] complained of tooth pain. Nurse was paged and he was informed to take ibuprofen. Lawyer [redacted] came in to see Remand [redacted].

He returned in the evening and was placed on ½ hr. observations.</p> <p>Inmate [redacted] was taken off special rec. and moved to regular rec with everyone else. His reason for having separate rec was transferred to the Farm.</p>
<p><b>Friday February 14th</b></p>	<p>KEMH visit: [redacted] and [redacted] was escorted to KEMH to see his aunt who is on her last</p>
<p><b>Saturday February 15th</b></p>	<p>Inmate [redacted] was placed on 15min suicide observations after reports of him stating that he is hearing voices. He was placed in D/Seg cell 1.</p>
<p><b>Monday February 17th</b></p>	<p>Inmate [redacted] was transferred to The Right Living House.</p>
<p><b>Tuesday February 18th</b></p>	<p>Inmate [redacted] was escorted to Court Services to have EMD fitted for release on Parole.</p> <p>Imp [redacted] was injured while playing football. He was seen by medical and given medication for his shoulder.</p>
<p><b>Wednesday February 19th</b></p>	<p>[redacted] was seen by [redacted] today, he has been taken off 15 minutes continuous suicide observations and placed on 30 minutes observations but to remain in Seg with limited items (no shoelaces, no sharp items etc).</p> <p>Discharge – [redacted] -Released by the Courts. State Now #104</p> <p>Imp [redacted] has agreed to take his meds.</p> <p>Reception: [redacted] -Numerous traffic violations \$610.00-or 31-days imp. <b>Friday February 21st</b>	1104hrs - Remand [redacted] was taken to KEMH via ambulance because his routine ECG test was abnormal. [redacted] went with him in the ambulance and [redacted] followed in the prison vehicle.  1550hrs – KEMH escort returned [redacted]
<b>Saturday February 22nd</b>	A search was conducted in E3 unit by [redacted] and [redacted] with the following item found in the upper shower between cells 38 and 40, in the light fixture. (4) cellphones, (2) pre-paid [redacted] sim cards, (5) chargers and cords, (1) blue cellphone battery, (1) large twist of plant-like material, (1) small bag containing (5) twist of plant-like material, (1) plastic twist of an unknown substance. The plant-like material was bag and handed over to [redacted] of the Bermuda Police Service.  1322hrs- [redacted] and [redacted] did another search in E2 and found the following items in the upper shower in the light fixture between cells #38 and 40. (1) White Figo cellphone, (1) broken charging block with a charging cord. Also, in the opposite upper shower in the light fixture between cells #10 and #12 was a homemade shank made with an old razor handle and rusty nail.
<b>Sunday February 23rd</b>	Brew was found in a mayonnaise bottle in Segregation by [redacted] and [redacted] in the storage room leading to D-Seg.
<b>Monday February 24th</b>	Special search conducted on inmate [redacted] housed in E2-13. One blue iPhone found in his legal documents. Also, search conducted on inmate [redacted] (1) cellphone cord and charging block, (1) lighter and (1) cedar door jammer. They have both been informed that they are on charge.  Reception: [redacted] - Offensive /Threatening Words / Behavior Remanded till 17/3/25 State Now #104  Discharged: [redacted] was released on probation with an EMD. State Now #103.  [redacted] went from AWS to 7 1/2 years imp with 277days T.I.C
