- "(1) By deleting clause 4 in its entirety and replacing it with the following:
 - 4. With the consent of the Minister, the Company has the power to hold land situate in Bermuda not exceeding 0.2409 hectares in all, including the following parcels as more fully described in Schedules 1 and 2 attached hereto.

And by renaming the Schedule to read Schedule 1.

And by adding a second schedule to be called Schedule 2 which shall read as follows:

SCHEDULE 2

- (i) pursuant to Section 42 of the Act, the Company shall have the power to issue preference shares which are, at the option of the holder, liable to be redeemed;
