- Work directly with Chief Risk Officer (CRO) and others within the Chartis ERM organization on various aspects of ERM implementation, such as:
 - Quantify and explain appropriate risk metrics for assumed business, including risk adjusted profitability measures
 - Drive ongoing developments of the suite of ERM tools & techniques, including Risk Registers and Scenario Analysis
 - Develop risk tolerance limits within the Risk Appetite Framework
- Prepare material for communication with internal and external stakeholders, including the BMA Risk Based Regulatory Filings
- Provide analytics for risk-return optimization underlying the terms of acceptance for underwriting risks
- Provide actuarial support, including ALM & valuation review
- Other duties arising as the business model evolves

- Professional qualifications: FCAS or ACAS/CERA or comparable accredited designation
