The company is seeking to hire an Assistant Vice President - Analysis to be responsible for supervising the review of the integrity and accuracy of underwriting information in property catastrophe & specialty reinsurance submissions. Data from submissions are modeled and analyzed to understand actual exposures, risks/ rewards and to provide actionable insights to underwriters.

## Duties and responsibilities will include but are not limited to:

- Manage TMR's complex portfolio of reinsurance accounts to effectively monitor risks and their associated rewards
- · Quantify expected profit and marginal risk distributions while identifying areas of concern and potential opportunity
- Prepare reports detailing information on portfolio optimization for management
- Perform catastrophe modeling in RMS/EQE/AIR and analyze the data produced
- · Review data for completeness and validity
- · Research and/or create adjustment factors for data and models for unquantifiable risk
- Incorporate upcoming changes and enhancements to modeling software into the risk quantification process
- Pricing of reinsurance contracts and review and sign off on all steps in the pricing process
- Adjust for model parameter uncertainties in the determination of real-world exposure including current and potential coverage, terms and conditions
- Accurately estimate correlations across all risks
- Manage and mentor the analysis team by monitoring workflow and provide training on risk analysis procedures
- · Verify accuracy of portfolio tools and methodologies developed both internally and externally
- Understand all components of the risk modeling process and model developments related to pricing, aggregation control and management of catastrophe risk
- Maintain and improve accuracy and efficiency of work flow processes
- Ad hoc projects as required

## Desired skills and experience include:

- A university degree in the field of Engineering, Applied Sciences, Economics, Mathematics, or a related field
- A minimum of 5 years experience in the reinsurance industry
