Key responsibilities include:

- Identifies and coordinates all engineering service requirements for all BHB sites
- Oversees and manages all on site inspections, assists inspectors and surveyors in their duties. Evaluates and determines the need to outsource contracted labour and services. Makes recommendations and provides reports as required in the follow-up to surveys, inspections and audits
- Interviews and evaluates the qualifications and competencies of sourced labour and designs orientation that integrates contractor's needs as well as hospital and department requirements
- Participates in the development of BHB's annual deferred maintenance budget and manages projects or those outsourced to ensure compliance with budget/cost, schedule and quality performance
- Consults and provides regular updates to the Chief Operating Officer; communicates daily and acts as key liaison person for Facilities and Redevelopment Project Office (RPO) regarding current activities, needs and challenges
- Develops an implementation plan for decommissioning keys services and plant such as boilers, chillers, water, etc.; supports and performs authorized duties for the HV, LV, MGPS systems and the CMMS system as required
- Monitors plant performance, provides guidance with operational matters, advises on the suitability of equipment; assesses and monitors facilities repairs to ensure cost effectiveness and quality control; recommends and advises on criteria for repair versus replacement of facilities
- Adheres to and ensures departments comply with all employee health and infection control policies

Qualifications &/ Registration required:

- Bachelors Degree in a civil, mechanical or electrical engineering discipline (Master's degree preferred)
- Must have at least 7 years experience at a similar level within Healthcare Premises and be familiar with infection prevention procedures and requirements
- Chartered Engineer or Professional Engineer with local certification by Bermuda Professional Engineers Council
- A strong proven background in Facilities Management, with an emphasis on Healthcare Buildings and their services with a sound understanding of the various National Standard and regulatory frameworks
- Demonstrated proficiency in Medical Gas Pipeline Systems, High & Low Voltage networks and equipment, including CCHP and boiler plant and emergency generators is imperative
- Knowledge of steam plant and chillers, water treatment systems and Sterilization equipment is essential
