The post-holder will also have frequent interaction with the SVP – Finance, and SVP – Treasurer of Platinum. This is a role which will provide a broad range of support to the financial reporting and treasury teams.

Key roles and responsibilities:

- Assist with group regulatory compliance efforts. Preparing and coordinating statutory filings, monitoring rules & regulations, establishing policies and procedures;
- Work on varying aspects of preparing accurate and timely consolidated group financial statements and materials for quarterly SEC reporting, senior management meetings and Board and Committee meetings. Will include involvement in parent company accounting, consolidation, use of financial

reporting software to prepare statements, footnotes and other schedules, and assistance with XBRL reporting;

- Work with the Investments & Treasury department and external investment accountants in the investment accounting and analysis process, including preparing quarterly reports for internal and external reporting;
- Maintain adequate internal controls over financial reporting and related documentation under Sarbanes Oxley Section 404. Liaising with both internal and external auditors. Enhance controls and documentation over processes, procedures and reporting in the finance and investment operations of Platinum Holdings;
- Conduct other ad-hoc analysis and projects as required by the Controller, SVP – Finance or SVP – Treasurer;

Qualifications, skills and experience

- The ideal candidate will have between 2-5 years of relevant post-qualification experience in the reinsurance industry or public accounting experience, with exposure to the insurance or reinsurance industry;
- A professional accounting designation is preferable; however consideration will be given to those with relevant work experience;
