The role requires a strong background in premium and cost monitoring, business process reviews and analysis, systems and controls, as well as an ability to troubleshoot any issues through to successful conclusion.

Responsibilities include:

- Manage all aspects of premium, claims and loss reporting from internal business unit level reporting, to external SEC, GAAP, statutory and US Reinsurance Trust reporting
- Assist with the generation of monthly and quarterly financial statements, supporting general ledger activity and legal entity reviews
- Maintain an appropriate SOX 404 control environment for the booking of premium, acquisition costs, and claims in the reinsurance accounting systems and general ledger
- Perform accounting reviews and analysis to ensure appropriate US GAAP accounting treatment
- Perform technical analysis of contracts and other FASB and SEC research
- Review and perform ongoing analysis and monitoring of reported claims, ensuring propriety of reported claims, and oversee the quarterly reserving process
- Manage the timely monthly close of the reinsurance systems
- Lead the continued enhancement of business processes for loss reserving and development of additional analytical tools for premium activity
- Participate in the implementation of the new reinsurance accounting platform and in any on-going refinement/improvements
- Manage the Reinsurance and Insurance annual budgeting process
- Monitor complex internal and external sessions, and sidecar activities
- Manage adhoc accounting projects, providing support to the Reinsurance Controller as needed
- Assist with annual GAAP and statutory financial statements and the coordination of annual audits
- Liaise with internal and external auditors and vendors
