HYDROGEOLOGIST PS30-32 \$92,096 - \$99,048 Department of Environmental Protection

The Government of Bermuda wishes to recruit an innovative and experienced individual to fill the post of Hydrogeologist.

Working under the supervision of the Environmental Engineer, and in accordance with the established policies, procedures, guidelines and relevant legislation the Hydrogeologist is accountable for managing the volume of the freshwater lenses and protecting and progressively enhancing the quality of all groundwater through effective management of the Water Right applications in accordance with the Water Resources Act 1975. The Hydrogeologist will dictate the cleanup, monitoring and reporting requirements to companies that are responsible for causing pollution incidents to the ground/groundwater and detailed in the "Risk based Corrective Action" (RBCA) Guideline for Bermuda. The post holder will also be required to participate in the development of research projects to effectively investigate longer term stressors to the ground water systems and near-shore marine environment.

Duties of the post include but are not limited to the following:

- compiling and analyzing field data and preparing charts, tables and reports as a basis for advising the Environmental Authority on the state of the water resources, recommending to the Environmental Engineer whether the Environmental Authority should grant new, or re-issue Water Rights;
- monitoring the volumes of the four main freshwater lenses every three (3) months using monitoring wells and numerate software packages including ArcView GIS;
- formulating research, monitoring, modeling and mitigation programs to address anthropogenic impacts to the groundwater due to abstraction, Waste Water Treatment Plants and road run-off;
- coordinating ground water pollution investigations and responding efficiently with on-site visits to pollution incidents while providing immediate advice of the requirements of the polluter as defined in the RBCA guidelines; and
- assisting with the developing of draft legislation and policy on behalf of the Environmental Authority to help mitigate known impacts to the groundwater as it relates to disposal boreholes of waste water treatment plants, HVAC systems, and aquaponic systems.

A minimum of a Bachelors of Science degree in Geology or a related discipline with a current membership of an internationally recognized and accredited professional body or association as a Geologist, Engineer or equivalent are required. The post holder must also possess a minimum of three (3) years' post qualification experience in hydrogeology which should include setting water abstraction limits, modeling groundwater flows, setting wastewater disposal conditions and monitoring water quality to sustain the groundwater resources.

The Hydrogeologist must be knowledgeable in the geology, hydrology and hydrogeology of Bermuda with the unshakeable ability to enforce relative legislation and codes. The post holder must have excellent oral and written communication, presentation, interpersonal, organizational, problem solving and research skills. Due to the nature of the post, possessing a valid driver's license with access to a vehicle for site visits and the ability to respond to environmental emergencies during off hours would be desirable assets.
