Duties and Responsibilities:

- Identify risks inherent in the business, collate key management information, and calculate risk exposure metrics to monitor and report on company risk profiles as part of the Bermuda risk management and actuarial team, in collaboration with multifunctional international groups.
- Serve as a key support role for the ERM Subject Matter Experts in various capacities, including:
 - Promote risk and capital modelling initiatives through data collection and analytic review; Conduct quantitative and qualitative
 - assessments O monitor the risk profile against risk appetite limits;
 - Support ongoing enhancements to the Risk Registers, by o ensuring all risks and risk mitigation techniques are well documented, consistently rated and quantified; Monitor the efficacy of risk mitigation techniques and
 - 0 controls;
 - Conduct analytic review of stress testing results; 0
 - Enhance risk awareness through development of ERM o training materials;
 - Develop a suite of process and procedural documentation O across the spectrum of risk categories; and
 - Prepare risk reports for presentation to key internal and o external stakeholders, including the Board Committees and Rating Agencies.
- Support the preparation and ongoing enhancements of BMA riskbased regulatory filings and assist with other risk-based regulatory initiatives.
- Foster successful management of internal projects at the legal entity and/or group level by liaising with the key functional teams, such as, strategic finance, capital management and ERM CAT modelling.
- Maintain and update information relating to pension plan participants and aid in the annuity valuation process.
- Any other assigned duties.

Qualifications and Experience:

- Undergraduate degree in risk management, business or actuarial science
- Minimum 5 years of post-graduate professional experience, with at least 3 years in the Insurance/Reinsurance sector with risk management related responsibilities (candidates with risk management, actuarial, underwriting or accounting backgrounds will be considered)
- Self-starter, results oriented thinker with the intellectual agility to support multiple projects successfully and work effectively in a fast-paced team environment.
- High aptitude for analyzing, and interpreting summarizing quantitative data and qualitative information, including strong written and verbal communication skills.
- Familiar with insurance concepts and terminology, including standard insurance performance measures and risk-adjusted metrics
- Ability to work in a collaborative fashion across business functions and with remote business partners.
