The Authority is seeking the services of a skilled individual to work as Principal (Investment Business) in our Banking, Trust and Investment Department. Reporting to the Assistant Director, the post holder will be responsible for the proactive coordination of an analytical team that is accountable for the supervision of a particular regulatory activity or operational area, which is directed by existing legislation and/or strategic business goals.

In this key role, you will be responsible for:

- Reviewing documents/reports and recommendations from the analytical team on regulatory or operational matters and determining appropriate courses of action;
- Undertaking risk-based analysis of licensed institutions and groups;
- Providing advice and senior level technical support to regulatory or operational teams within the various areas of the Department;
- Managing and motivating performance, while also overseeing the development of associates in the achievement of ideal results, through the effective use of teamwork;
- Representing the Authority on various local and international committees
 and through attendance at seminars and conferences with other regulatory
 bodies and governmental agencies involved in the financial services industry;
- Providing advice and senior level technical support for policy and other initiatives affecting the Department/team;
- Performing other related work and special projects as assigned by management.

This position requires a proven technical and business background. As such the post holder must possess:

- Master's Degree in a relevant discipline, such as Business, Finance, Economics or Law and a relevant professional qualification such as CA, CPA, CFA, FRM;
- A minimum of seven (7) years' post graduate experience, of which at least three (3) years should be at a senior level working within a regulated financial services business, preferably Banking, Trust, and/or Investment sector, or as a financial services regulator;
- A sound understanding of financial analysis techniques, as well as risk management and corporate governance issues;
- In-depth knowledge of investment organisations and good understanding of credit, market and operational risk;
- Proven experience with internal auditing, compliance and risk management (including enterprise wide risk management, ERM);
- Good knowledge of relevant international regulatory standards, in particular, those relating to IOSCO;
- A high degree of personal commitment and an ability to work under pressure;
- Exceptional analytical and communication skills (written and oral);
- Confidence in speaking and conducting meetings;
- Working knowledge of computerized systems and databases, particularly Microsoft suite of products.
