CUSTOMS DUTY (QUANTUM COMMUNICATIONS LIMITED) REMISSION ORDER 2013

BR 8 / 2013

The Minister of Finance, in exercise of the power conferred by section 2 of the Customs Duty (Special Remission) Act 1951, makes the following Order:

Citation

1 This Order may be cited as the Customs Duty (Quantum Communications Limited) Remission Order 2013.

Interpretation

2 In this Order—

"the Act" means the Customs Duty (Special Remission) Act 1951;

"goods" means materials, equipment, apparatus and machinery;

"undertaking" means the building of an Island-wide high speed fibre-optic telecommunication network.

Exemption from import customs duty

3 For the purpose of the undertaking, Quantum Communications Limited (the "exempted person" for the purposes of the Act) is granted, in respect of the goods, complete exemption from the payment of import customs duty that would otherwise be payable under section 2 of the Customs Tariff Act 1970.

Commencement and expiration

4 (1) This Order is deemed to have come into operation on 1 September 2012.

(2) This Order expires on 31 March 2017.

(3) Goods which have been exempt from import customs duty by virtue of paragraph 3, shall not be subject to import customs duty by reason only that this Order has expired.
