Senior Officer - Network Management Management Services Department

The Bermuda Monetary Authority is seeking the services of a highly skilled professional to work as a Senior Officer - Network Management within our Management Services Department. The successful applicant, working under the direction of the Director of Management Services will have as his/her primary role the design, development and maintenance of a "best-in-class" technology infrastructure in support of an innovative regulatory and supervisory framework.

In this key role, you will be responsible for:

- Administration and maintenance of mission critical application, database, and web servers (predominantly Microsoft, some Linux) hosted mainly within the Authority's own data centre, but also externally;
- Assisting in the design, implementation, and maintenance of systems, programs, hardware and software in a high availability Cisco / VMware / Windows environment;
- Administering a high-availability Exchange email cluster for company-wide email and for the management of email handling systems across domains;
- Managing complex troubleshooting and resolving network and telephony technical issues, overseeing and coordinating configuration changes, maintaining accurate documentation, systems backups, archiving, as well as ensuring disaster readiness;
- Overseeing external contractors performing highly complex projects with high visibility and high impact on the business.

This position requires a proven technical and business background, and as such the post holder must possess:

- Master's Degree or equivalent qualification in Computer Science, Information Systems Management or related subject for a recognized institution. Candidates possessing a Bachelor's Degree in computer science or a related equivalent plus MCITP or MCTS or MCSE together with one or more related certifications i.e. VCP, HP SAN, CCNA will also be considered;
- Minimum of seven (7) years post qualification experience which includes a sound and practical knowledge of best practice network management in a complex financial services entity;
- The ability to quickly understand and be able to articulate business impacts of technical decisions and drive solutions to specific business problems through the effective use of technology;
- Ability to articulate solutions to such diverse constituencies as project managers, vendors, business stakeholders, and engineers as well as possess comprehensive technical knowledge and organizational skills;
- Individuals with financial services industry experience will receive preference.
