The Minister responsible for marine and ports services, in exercise of the power conferred by section 10(1)(a), (aa) and (b) of the Marine Board Act 1962, issues the following Notice:

This Notice may be cited as the Marine Board (Control Over Maritime Traffic) (No. 5) Notice 2013.

## Interpretation

"chart" means the chart set out in the Schedule;

"boat" includes a personal water craft (commonly referred to as a jet ski) for the purpose of an offence under section 10(3)(a) of the Act;

"boatman" includes the operator of a personal water craft;

"five-knot no wake zone" means all the waters of Mangrove Bay, Somerset southwest of a line between the Boaz Island Gas Station and the easternmost island at the tip of King's Point, indicated as the diagonally lined area and the hatched area on the chart;

"the Race" means the Non-Mariners Race;

"race area" means the waters of Mangrove Bay, Somerset, southwest of a line between the southern end of Watford Bridge and the easternmost island at the tip of King's Point, indicated as the hatched area on the chart.

#### **Non-Mariners Race**

3 The Non-Mariners Race will be held within the race area on Sunday 4 August 2013 from 10:00 a.m. to 8:00 p.m.

## Speed limit

All mariners, pilots and boatman must observe a five-knot no wake restriction while navigating the waters of Mangrove Bay within the five-knot no wake zone.

## Personal water craft prohibited in race area

During the Race, a boatman who operates a personal water craft is prohibited from entering the race area.

## Patrol of waters


6 The waters of Mangrove Bay will be patrolled by the Marine Police during the Race, and all mariners, pilots and boatman are required to exercise caution when approaching or navigating the race area due to the presence of swimmers and numerous boats at anchor or moored together.

7 Failure to observe the requirements set out under paragraphs 4 and 5 of this Notice is an offence under section 10(3)(a) of the Marine Board Act 1962.
