This position is responsible for coordinating, planning, consolidating and reporting on the financial activities of the group and reports directly to the Chief Accounting Officer, and will involve direct interaction with various levels of Executive Management and Audit Committee Members.

KEY RESPONSIBILITIES:

- Ensure quarterly reporting is completed on a timely basis; including the preparation of supporting schedules for external parties, senior management, the Audit Committee and Board of Directors;
- Planning, preparation management and review of quarterly close processes including consolidated results and required tax returns;
- Oversee group general ledger on a group wide basis;
- Preparation of SEC filings;
- Manage and oversee the group Equity Compensation and Financial Reporting teams and liaise with global HR teams;
- Coordinate activities of external auditors; direct financial audits and provide recommendations for procedural improvements;
- Participate in the determination and documentation of relevant policies and procedures;
- Supervise record keeping and set up controls;
- Daily management of a number finance staff members and seconded personnel including periodic/annual appraisals and recruitment as necessary;
- Assist with establishing and implement short and long-range finance team goals, objectives, policies, and operating procedures;
- Supervise preparation of annual financial statements and audit working papers;
- Maintenance and delivery of US GAAP financial statements to the Chief Accounting Officer and Chief Financial Officer;
- Month end close, reconciliation, budgeting and forecasting including key management reporting metrics;
- Preparation of internal and external reports for multiple jurisdictions;
- Supervise and coordinate strategic Finance programs and act as the Group Finance liaison with the IT Department;
- Other duties as required.

The successful candidate should meet the following requirements:

- Internationally recognized accounting designation (i.e CA, ACA, CPA,) with a minimum of 10 years relevant finance experience, including 5+ years senior supervisory experience in a large publicly traded global reinsurance company;
- Extensive knowledge of US GAAP, accounting and experience in reinsurance accounting required;
- Extensive experience with SEC reporting and filing required;
- CEP designation an asset;
- Experience with IFRS reporting and internationally recognized designation preferred;
- Hands on experience with the following automated financial and accounting reporting systems – SUN, Solium, Webfilings, Corporate Focus and XBRL;
- Proven ability to motivate teams to produce quality materials within tight timeframes and simultaneously manage numerous projects;
- Proven experience in the building and management of teams under a recognized, formal strategy and program.
