Air Cargo Development

The Bermuda Government, Ministry of Tourism Development and Transport, Department of Airport Operations (DAO) is issuing Expressions of Interest (EOI) for a sole operator to build and operate a new Cargo Terminal.

The Airport has considered several plans and proposed layouts for development and an optimal design was included in the Airport Master Plan. DAO would like to investigate the possibility of having these areas developed privately either through a design-build or a design-build-operate-maintain process. Thus, this EOI is seeking information from organizations that may be interested in designing and constructing a cargo handling facility and new apron space at the airport and/or developing an interim operation according to the Options described in the EOI.

DAO in its sole discretion, may issue a future formal request for proposal (RFP); modify the project in whole or in part; take no further action regarding this project; or exercise any other available options. Any proposals would be evaluated in conjunction with H.M. Customs Bermuda.

Project Objectives

The DAO strives to satisfy the needs of all of its customers by facilitating the processing of all passengers and cargo in a safe, secure and proficient manner. It would like to meet all applicable International Civil Aviation Organization (ICAO) standards in order to realize Bermuda's full cargo potential and to reach the Master Plan goal of providing a world class airport that is both functional and sustainable.
