## MISUSE OF DRUGS AMENDMENT REGULATIONS 2014

## BR 23/ 2014

The Minister responsible for drug prevention, in exercise of the powers conferred by sections 14 and 38 of the Misuse Of Drugs Act 1972, makes the following Regulations:

**Citation**

1 These Regulations may be cited as the Misuse Of Drugs Amendment Regulations 2014.

**Amends Schedule 2**
