Responsibilities will also include but will not be limited to:

- Assist with the preparation of schedules required for the compilation of quarterly reports and other external documents such as SEC filings;
- Prepare other financial reports and information for other Holdings finance team members as required;
- Maintain good internal control procedures and ensure compliance with Sarbanes Oxley regulations;
- Liaise with external auditors as needed;
- Other duties as required.

- Current CA, CPA, ACA or other equivalent accounting designation required;
- Thorough and current knowledge of US GAAP;
- A minimum of 2-3 years similar professional accounting experience at a publicly traded reinsurance company or Big 4 Accounting firm or experience within the reinsurance industry preferred;

- Experience with SUN GL reporting system an asset;
- Proven organizational, self management and timekeeping skills and a strong sense of attention to detail are essential;
