- Contribute proactively to continuous improvement culture, identifying, developing and implementing process improvements in assigned areas of responsibility
- Ad hoc research, analysis and documentation of accounting issues under U.S. GAAP
- Build strong working relationships with finance community and general management at operating companies and regional/global functions in order to expand knowledge and transfer best practices
