- Regular (at least quarterly) reporting on all relevant risk
- Ensure that Risk Assessment and Risk and Control Self-Assessment processes are carried out and deliver high quality results
- Support the production of relevant risk MI including risk event reporting, to ensure management is kept apprised of changes in the profile of all risks and in particular any risks which are near or in excess of their appetite
- Attend management committee meetings, as appropriate, to represent ERM and provide input, review and challenge to ensure risks are managed effectively by the business and escalated as appropriate
- Support the effective running and transformation of AIG through various activities including sponsorship of projects, а active management of crisis situations and close collaboration with the business and the other functions
- Support the provision of risk information to local regulatory and rating agency requirement, including capital requirements based on internal capital views if applicable Monitor adherence to the risk-related AIG Policies
- Maintain an effective Risk Management Operating Model which enables the comprehensive identification, analysis, and reporting of relevant risks. This includes an efficient Risk Event capture process.
- Implement and support a risk-based RCSA program to ensure that the more significant risk areas are identified and assessed and that the appropriate remediation efforts are tracked
- Continue to promote operational risk awareness and embed an operational risk culture by facilitating training and engaging the varied levels of management in the organization
- Support the business in the identification of strategies that optimize financial performance within the constraint of the risk appetite / available capital (as applicable). This includes business mix, planning, reinsurance coverage, investment mix (as applicable), etc. other
- Work closely with the regulatory team and the assurance functions, develop a positive working relationship with regulators across the region.
- Ensure that the AIG Risk Management Framework meets local risk management requirements.
