NORTH SHORE ROAD, DEVONSHIRE NEAR TYNES BAY

This Ministry wishes to inform motorists there will be a road closure on North Shore Road, Devonshire near the Tynes Bay incinerator entrance, to allow road excavation works take place across the entire road width of North Shore Road. The road works is required to create a new salt water pipe line for the incinerator plan. The road works is schedule to take place on Friday 14th November, 2014 at 8.00pm and will continue until Saturday 22nd November, 2014, at 7.00pm. North Shore Road will be closed to traffic from the junction with Palmetto Road to the junction at Dock Hill. Resident's access will be provided only at the Dock Hill junction for their properties.

DETOURS

All traffic travelling in easterly direction on North Shore Road when reaching the junction with Dock Hill and North Shore Road will be directed towards Palmetto Road.

All traffic traveling in westerly direction when reaching the junction with Barkers Hill and North Shore Road will be directed towards Palmetto Road.

BUS SERVICES

The Bus Services on North Shore Road from Dock Hill junction to the Palmetto Road junction will be terminated while these works take place. We therefore ask that bus patrons not use this closed section of North Shore Road while these road works take place. The bus patrons must move to bus stop locations outside the road section mentioned here to receive bus services.

Should there be inclement weather, this road works will be postponed until the next available day until completion.
