Reporting to the SVP – Chief Investment Officer and Treasurer, the successful candidate will be responsible for ensuring the efficient and accurate performance of the treasury and investor relation functions. The role will involve maintaining and building relationships with investors, equity analysts, rating agencies and banks, as well as supporting risk and capital management across the Group.

### Responsibilities include:

- Maintain relationships with rating agencies, serve as the primary point of contact, coordinate data gathering processes and facilitate rating agency meetings
- Analyze impact of corporate actions on rating agency capital requirements
- Maintain relationships with the banks and serve as one of the key points of contact
- Ensure compliance with existing facilities, and develop strategy and process for establishing new credit and collateral facilities
- Coordinate with risk team for the roll up of the Company's overall capital, liquidity and risk profiles
- Assist with managing capital and liquidity across the Group
- Build models and frameworks for facilitating capital and liquidity decisions
- Assess financing alternatives presented by external advisors and make recommendations to Treasurer and CFO
- Develop capital plans to efficiently match the Group's balance sheet with current and future capital and liquidity requirements
- Coordinate with the senior executive team in implementing capital market transactions
- Serve as a key resource for the senior executive team in making capital structure and capital deployment decisions
- Develop and maintain effective relationships with analysts, institutional investors, financial journalists and regulators, acting as the prime point of contact
- Serve as primary contact for all shareholder inquiries and investor requests for information
- Monitor the Company's institutional and other ownership and trading trends, targeting investors accordingly
- Monitor the markets' response to Company results, keeping executive management informed
- Conduct industry and peer competitive analyses to help inform strategy

- Assist with planning and managing the annual investor relations event calendar, including investor conferences and road shows, along with investor outreach
- Oversee quarterly earnings calls including content development, conference call scripts and Q&A
