GOVERNMENT FEES AMENDMENT REGULATIONS 2015

BR 9 / 2015

The Minister of Finance, in exercise of the power conferred by section 2 of the Government Fees Act 1965, makes the following Regulations:

Citation

1 These Regulations may be cited as the Government Fees Amendment Regulations 2015.

Amends Schedule

2 The Schedule to the Government Fees Regulations 1976 is amended in Head 6—

(a) in the introductory wording to paragraph (5), by deleting “paragraphs (7) (c) and (8)” and substituting “paragraph (8)”;

(b) by deleting paragraph (5)(a)(iv) and substituting the following—

“(iv)	(a) a three-month short term permit	\$585
	(b) a four-month short term permit	\$685
	(c) a five-month short term permit	\$785
	(d) a six-month short term permit	\$885
	(e) a short term permit on an expedited basis (Note: Where applications are submitted for more than one expedited short term permit, the additional fee of \$500 will not exceed \$2,500, provided all applications are submitted at the same time by the same applicant.)	the application fee plus \$500” ;

(c) in paragraph (5)(a)(vi) by inserting after “musicians” the words “(Note: For applications submitted for 6 or more persons, a group fee of \$500 will apply)”;

(d) in paragraph (5)(a)(vii) to (xi) by inserting before “permit” the words “standard or periodic work”;

(e) by deleting paragraph (5)(a)(xii);

(f) in paragraph (7)(a) and (b) by deleting “(xii)” and substituting “(xi)”;

(g) by deleting paragraph (7)(c);

(h) by deleting paragraph (21) and substituting the following—

“(21) Applying for a—

(a) one-year global work permit	\$1,625
(b) two-year global work permit	\$2,885
(c) three-year global work permit	\$3,935
(d) four-year global work permit	\$4,985
(e) five-year global work permit	\$6,193”;

(i) in paragraph (22) by deleting “Permission-in-principle” and substituting “Advertisement extension”;

(j) by inserting the following after paragraph (22)—

“(22A) Applying for a—

(a) one-year new business work permit	\$1,625
(b) two-year new business work permit	\$2,885
(c) three-year new business work permit	\$3,935
(d) four-year new business work permit	\$4,985
(e) five-year new business work permit	\$6,193

(22AB) Applying for a global entrepreneur work permit (one-year) \$1,625”.

REVENUE (SIMPLIFIED CUSTOMS DECLARATION) (AMERICA’S CUP) NOTICE 2015

BR 10 / 2015

The Collector of Customs, in exercise of the powers conferred by section 35A of the Revenue Act 1898, makes the following Notice:

Short title

1 This Notice may be cited as the Revenue (Simplified Customs Declaration) (America’s Cup) Notice 2015.

Interpretation

2 In this Notice, “35th America’s Cup” has the meaning assigned by section 2 of the America’s Cup Act 2015.

Application of this Notice

3 This Notice does not apply to goods of Headings 87.01 through 89.08 inclusive of the First Schedule to the Customs Tariff Act 1970 (vehicles, aircraft, vessels and associated transport equipment).

Authorisation to use simplified tariff

4 A person importing goods that—

(a) are for use in connection with the holding of the 35th America’s Cup; and

(b) qualify for temporary importation relief under the Sixth Schedule to the Customs Tariff Act 1970,

may declare in a customs declaration that those goods are classified under heading 98.03 of the First Schedule to the Customs Tariff Act 1970 instead of declaring that those goods are classified under any other heading that applies to the goods.

Commencement and expiration

This Notice shall have effect from 28 February 2015 and expires on 1 November 2017.
