## Senior Advisor - Financial Stability

### Macroprudential Unit

The Authority is seeking the services of a skilled, capable and experienced individual for the position of Senior Advisor - Financial Stability. Reporting to the Chief Executive Officer, the incumbent will have responsibility for the Authority's activities as they relate to Macroprudential policy development and surveillance, regulatory (macroprudential) policy and oversight, crisis handling and resolution.

#### In this key role, you will be responsible for:

- Providing advice and direction to a team of professionals undertaking research and analysis of systemic risk and emerging vulnerabilities in the financial sector both domestically and internationally;
- Identifying incipient or actual system-wide vulnerabilities or threats, together with early warning indicators and developing policies to address such vulnerabilities;
- Identifying specific vulnerabilities or threats affecting individual (or groups of) financial institutions or markets, together with developing regulatory/supervisory measures to address such vulnerabilities;
- Developing, preparing and implementing crisis management continuum activities where instability might threaten Bermuda's financial sector;
- Serving as Secretary to the Financial Stability Committee and the Financial Stability Council;
- Representing the Authority at various local, regional and international meetings, conferences and seminars with other regulatory bodies, government agencies and the financial services industry as required.

#### This position requires a proven technical and business background and therefore, the post holder must have:

- A Master's Degree or equivalent qualification from a recognized institution or professional body in a discipline related to the financial services sector (i.e. Finance, Economics, Banking, Insurance, etc.);
- A minimum of fifteen (15) years relevant post graduate experience, of which at least five (5) years should be at a senior level managing a team. Candidates with current regulatory/supervisory experience, specifically in the area of financial stability and macroprudential regulation are preferred;
- Sound understanding and knowledge of international financial service regulations;
- Strong administrative, organisational and project management skills;
- Excellent management, leadership and interpersonal skills with the ability to build and maintain key relationships across the Authority and with external groups including the Ministry of Finance, other Central Banks and regulated organisations;
- Collaborative and diplomatic with excellent judgment and communications skills.
