TRUST ACCOUNTANT

This position will be responsible for all aspects of the trust accounting and reinsurance accounting for the collateralized reinsurance business. The candidate will be required to prepare financial statements and reports for the collateralized reinsurance business. In addition, he/she will be required to administer trust accounts including issuance of precautionary notices of cancellation for expiring trusts, closing of trust accounts and return of the necessary collateral. The successful candidate will also be responsible for management of the collateral ledger, impairments ledger and cash balance for each trust.

Duties and Responsibilities:

- All aspects of trust accounting and maintenance of ledger entries for the collateralized reinsurance entities.
- Coordinate the opening, closing, funding of trust accounts.
- Record activity within the trust including premiums received, loss payments out, etc. using the Insurance system.
- Preparation of contract valuations for external reporting
- Reconciliation of Trust activity monthly to the general ledger, contract, etc.
- Preparation of drawdown requests for internally managed trust accounts.
- Maintenance of collateral ledger.
- Assist with internal and external SEC and regulatory reporting required for Funds and other Collateralized Reinsurance entities.
- Ad hoc projects as necessary.

Required Skills / Qualifications:

- Accounting qualification required (CA/CPA/CMA/ACCA) along with relevant university degree.
- Minimum of 3-5 years insurance/reinsurance industry experience, including public company reporting preferred.
- Knowledge of fund accounting would be an asset.
