



## **Vice President, Investments and Treasury**

Reporting directly to the Chief Investment Officer (CIO), the Vice President, Investments and Treasury is responsible for the following not limited to:

- Assist with oversight of the Company's outsourced investments and supervision of third party investment managers and investment accountants;
- Assist CIO with analysis of new investment opportunities as needed;
- Ensuring proper investment accounting controls are maintained within the Group, including review of all internal investment reporting by other finance team members and ownership of the accuracy of investment details for internal and external reports.
- Management of third party investment custodian and banking relationships;
- Monitoring and forecasting group-wide cash positions to ensure that appropriate liquidity level is maintained;
- Providing a rolling, quarterly cash flow forecast for Group CIO and CFO, incorporating inputs from segment CFOs or other finance team members;
- Ensuring proper funding/receipt of capital calls/distributions from various alternative investment manager relationships;
- Preparation of weekly, monthly and quarterly management/group investment reports, performance and related support including reporting to senior group management and the board;
- Development and interpretation of detailed analytical information;
- Primary responsibility for drafting and maintaining public company disclosure reporting;
- Maintenance and renewal of financing facilities, including regular compliance documentation;
- Development and execution of foreign currency hedging function in compliance with Group F/X hedging policy and reporting on such activity and results to group F/X committee;
- Maintaining appropriate collateral accounts for derivative exposures (i.e. interest rate swap);
- Efficient management of underwriting related LOC and trust collateral requirements to meet necessary requirements while optimizing group investment flexibility;
- Preparation of Sarbanes-Oxley and Solvency II compliance documentation, remediation processes and SSAE 16 reviews;
- Maintain the functionality and administer computer based investment, banking and credit programs (Bloomberg, HSBC.net, TradeChannel, etc.).

- Bachelor's degree or equivalent in accounting or related field;
- Current CA, CPA, ACA or other equivalent accounting designation required;
- CFA or CAIA designation preferred;
- A minimum of 7-10 years' similar professional accounting experience at an international company;
- Fixed income and alternative investment experience required;
- Reinsurance industry experience required;
- Proven knowledge of US GAAP, specifically investment related FAS.
