

## Required skills and experience

The successful candidates will have the following skills and experience:

#### **Experienced Associate**

- Bachelor's degree from an accredited university;
- Minimum 1.5 years of relevant IT audit experience gained working in a Big 4 or consulting environment;

- Experience in performing IT audits in support of an external audit is essential, experience of PCAOB audit standards is preferred;
- Ability to effectively integrate and communicate with both clients and members of the Assurance teams:
- Experience working on SSAE16 reports and/or experience in SOX controls auditing is preferred.

#### Senior Associate

- · Bachelor's degree from an accredited university;
- Candidates should hold either an accounting qualification (CPA, ACCA, CA, ACA or equivalent) or the CISA designation along with a degree in Computer Science or Information Systems;
- Additional IT and audit qualifications (e.g. QiCA, CRISC or CIA) are desirable but not mandatory;
- Minimum 4 years of relevant IT audit experience gained working in a Big 4 or consulting environment;
- Experience in performing IT audits in support of an external audit is essential, experience of PCAOB audit standards is highly preferred;
- Candidates should also have experience using ACL or other Computer Aided Audit Tools (CAATs); and
- Ability to effectively integrate and communicate with both clients and members of the Assurance teams.

#### Manager

- Bachelor's degree from an accredited university;
- Minimum of eight years relevant IT audit and advisory experience, preferably gained in a public accounting firm;
- Relevant professional qualification (e.g. CISA/QiCA or CA/CPA/ACA);
- Experience in the use of CAATs and Data analysis software tools, including ACL, SAS and Microsoft SQL Server;
- Strong working knowledge of IT control best practices in a Sarbanes-Oxley compliant environment as well as experience in ISAE 3402/SSAE16 reviews; and
- Familiarity with using CAATs to perform journals analysis as part of an
  external audit and ability to advise assurance teams on designing testing
  in this area. Knowledge of Audit Standards/GAAS relevant to this area will
  also be an asset.
- In addition to strong analytical skills, the successful candidate will have proven relationship building/client management experience in a consulting environment as well as excellent organizational and communication skills.
