(2016 TO 2017 SCHOOL YEAR) AMENDMENT ORDER 2016

BR 100 / 2016

The Minister responsible for education, in exercise of the power conferred by sections 5(1) and 20(3) of the Bermuda Educators Council Act 2002, makes the following Order:

Citation

1 This Order may be cited as the Bermuda Educators Council (Exemption) (2016 to 2017 School Year) Amendment Order 2016.

Amends Schedule

2 The Schedule to the Bermuda Educators Council (Exemption) (2016 to 2017 School Year) Order 2016 is amended by inserting the following in their proper alphabetical order—
