#### **Group Chief Actuary**

CRO duties will include continued development and implementation of an effective risk management framework and responsibility for compliance and related reporting. The individual will develop the Risk Management framework incorporating shareholders risk appetite and embed the framework to enable better strategic decisions through effective analysis of risk verses return.
