Citation

1 This Notice may be cited as the Marine Board (Control Over Maritime Traffic) (No. 2) Notice 2017.

Continental Cup Triathlon Swim Races

2 The Continental Cup Triathlon Swim Races will take place within Hamilton Harbour on Saturday 8 April 2017 and Sunday 9 April 2017.

Closure of certain sections of Hamilton Harbour

3 The area of Hamilton Harbour between the east face of Albouy's Point and mid-way of Hamilton 5/6 berth, out to a distance of approximately 550 feet (outlined in the Schedule) will be closed to normal marine traffic on—

- (a) Saturday 8 April 2017 between the hours of 9:00 am and 9:30 am; and
- (b) Sunday 9 April 2017 between the hours of 10:00 am and 11:45 am.

Patrol of course

4 Marshal boats will be on patrol, and all mariners, pilots and boatmen are required to keep clear of, and exercise caution when approaching the area of Hamilton Harbour referred to in paragraph 3.

Offence

5 It is an offence under section 10(3)(a) of the Marine Board Act 1962 for the master of a ship or boat to fail to observe the requirements set out in this Notice.
