The Senior Reinsurance Accountant will play a key role in the accounting for our Property and Casualty/Specialty segments with a focus on monitoring the Company's premiums and claims information.

Responsibilities include:

- Assist with all aspects of monthly and quarterly reinsurance premiums and claims reporting from internal business unit level reporting to external SEC, GAAP, statutory reporting and US Reinsurance Trust reporting
- Maintain an appropriate S.O.X 404 control environment for the booking of premiums and claims in both the reinsurance accounting systems and the general ledger
- Perform detailed analysis and reconciliation of assumed/ceded premiums and claims to ensure a thorough understanding of reported results, troubleshooting any issues through to a successful conclusion
- Assist with complex, internal and external cessions as well as joint venture activities including monthly underwriting estimates and fee calculations, quarterly accruals and billings and other adhoc support as needed
- Assist with premium and receivable reconciliations on a monthly basis
- Perform accounting reviews and analysis to ensure appropriate U.S. GAAP accounting treatment
- Assist with technical analysis of contracts and other FASB and SEC research
- Assist with the timely monthly close of the reinsurance systems
- Assist with the quarterly reserving process
- Assist in the generation of monthly and quarterly financial statements, supporting general ledger activity and legal entity reviews
- Perform monthly analysis of underwriting activity for subsidiaries
- Assist with the annual budgeting process
- Liaise with internal and external auditors and actuaries
- Participate in on-going refinement/improvements of business processes and the reinsurance accounting platform ensuring that the Bermuda Reinsurance Finance team needs are met
- Assist with annual GAAP and Statutory financial statements and the coordination of the annual audits
- Perform adhoc accounting projects and provide support to the Finance team as needed
