Primary Responsibilities include (but are not limited to):

- Handle all server upgrades/optimization tasks, manage new plans integration and produce billing lifecycle activities; also include the management of all critical processes including rating, billing, printing/ distribution and settlement
- Creation and management of a data warehouse, the production of reporting systems for stakeholders and the participation in projects with commercial and financial teams
- End-to-End processes of the entire billing process part of the order-to-cash process, including all credit controls and payment methods
- Periodic review of the billing processes and systems used to deliver the billing to ensure that they are maintained and optimal to meet demands by the organization
- Performance Management: KPI development and reporting for major areas (i.e.. availability, performance, major issues.)
- Vendor Management: Liaising and working with suppliers/vendors for escalation, negotiation, contracts, and new product assessment
- Work closely with customer service, marketing, sales and with various vendors involved with the billing solutions to implement new or updated rate plans, define enhancements, and escalate/resolve functionality defects and in the resolution of daily operational issues and system failures across the billing and customer care systems
- Develop and provide reporting systems for various internal clients and generate routine ad-hoc reports as required in addition to what is available in the billing system
- Provide systems to finance teams to ensure revenue assurance
- Assist in the design of products and services especially related to developing pricing models and forecasts
- Develop KPI reporting systems and participate internal review meetings to validate data models
- Produce and address all ad hoc data report and MIS requests

The successful candidate will possess the following qualifications, skills and experience:

- Bachelor's degree in Commerce/Information Systems/ Software Technology and a minimum of ten (10) years prior equivalent experience required
- 5+ years' experience in creating SQL queries, Crystal Reports or similar reporting tools and expert capabilities with MS Excel
