- A minimum of 8-10 years of post-qualification experience in a reinsurance environment, with a minimum of 5-7 years of direct supervisory experience;
- Extensive experience in reinsurance accounting (assumed, ceded and ILS) and reinsurance underwriting systems is essential;
- Expert level MS Excel skills required, including the maintenance and development of macros using the Visual Basic programming language; proficiency in MS Office, and MS Office 'Power' Business Intelligence;
- Proficiency with SICS v4.4.x policy management system and Business Objects required. SUN GL systems and Active Risk Manager preferred;
