BERMUDA NATIONAL PARKS (FEES) REGULATIONS 2018

BR 16 / 2018

The Minister responsible for parks, in exercise of the power conferred by section 25(1)(fa) of the Bermuda National Parks Act 1986, makes the following Regulations:

Citation

1 These Regulations may be cited as the Bermuda National Parks (Fees) Regulations 2018.

Interpretation

2 In these Regulations—

 “Act” means the Bermuda National Parks Act 1986;

 “National Park System” shall be construed in accordance with the provisions of section 3 of the Act; and

 “year” means a calendar year.

Fees

3 The following fees set out in the Schedule, being fees not prescribed under the Government Fees Regulations 1976, are payable in relation to admittances to certain parks and provision of goods and services, and all fees received shall be paid into the Consolidated Fund—

(14)	Purchase of a native and endemic plant in a 15 gallon size pot (with a voucher from the Department of Planning).	\$150
(15)	Purchase of a native and endemic plant in a 1 gallon size pot (without a voucher from the Department of Planning).	\$10
(16)	Purchase of a native and endemic plant in a 3 gallon size pot (without a voucher from the Department of Planning).	\$50
(17)	Purchase of a native and endemic plant in a 15 gallon size pot (without a voucher from the Department of Planning).	\$200
(18)	Rental of a small decorative plant pot arrangement.	\$75 per day
