 - Working with controller, ensure the work of the finance team is directed and organized to meet all internal and external reporting deadlines and all compliance standards
 - Establish appropriate planning and budgeting process to produce a reliable and credible financial plan
 - Build relationships with external banking and investment partners to ensure pro-active and prudent management of the company's pension, investment and debt portfolios
 - Assist the CFO in building a successful investor communications program
 - Work with other members of the senior team to position the company for a future listing on a North American exchange;
 - Provide the necessary leadership and communication to operate effectively as a senior leader at the Company;
 - Advise the CFO and other key members of senior management on capital markets and financial policy matters;
 - Represent the organization externally, as necessary, particularly in banking, investment and pension arrangements;
