# THE COMPANIES ACT 1981

**NOTICE IS HEREBY GIVEN that Bermuda Housing Corporation** is applying to incorporate a local company with limited liability to be called:

# Bermudiana Development Company Limited

Which shall have the following primary objects:

- 1. To acquire and hold in its corporate name and to redevelop as a condo hotel resort the land more particularly described in the Schedule hereto ("the Land") or any part thereof or any interest therein or in any part thereof and to market, sell, exchange, mortgage, lease and otherwise deal in and dispose of the same.
- 2. To redevelop, improve and generally deal with the Land and to construct buildings or works of every description and to pull down, rebuild, enlarge, alter, improve and upgrade existing buildings or works on the Land, and to convert and appropriate any part of the Land into and for roads, car parks, gardens, resort leisure amenities and any other convenience.
