NOTICE 2018**

The Minister responsible for legal affairs, in exercise of the power conferred by section 22 of the Bermuda Bar Amendment Act 2018, issues the following Notice:

Citation

1 This Notice may be cited as the Bermuda Bar Amendment Act 2018 Commencement Notice 2018.

Commencement

2 The following provisions of the Bermuda Bar Amendment Act 2018 come into operation on 25 September 2018—

- (a) section 1;
- (b) in section 2, the definition of “director”, “controller” and “senior executive”;
- (c) section 3;
- (d) sections 12, 13 and 14;
- (e) sections 17 and 18;
- (f) section 20; and
- (g) section 22.
