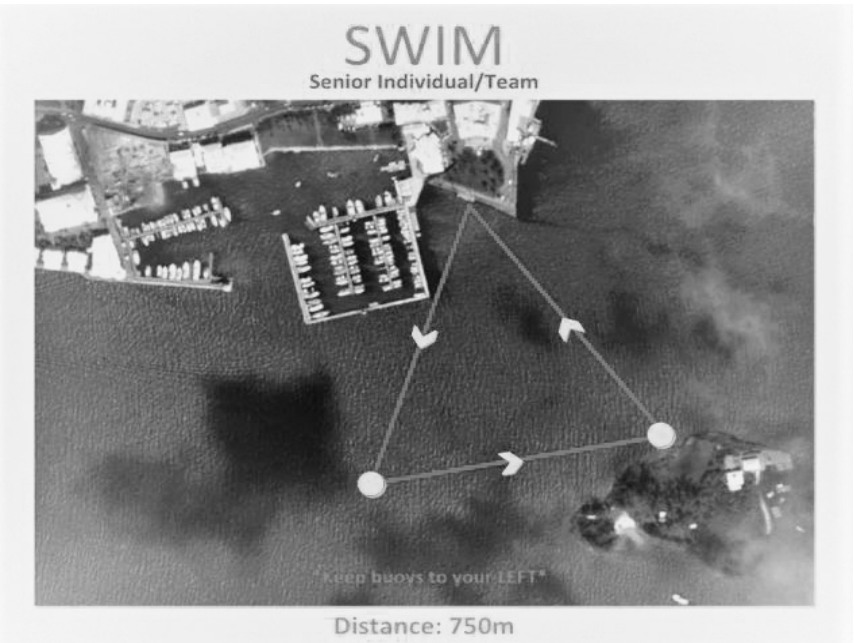
Triathlon Swim Race
