- Lead and manage a large team providing a full range of fund accounting/administration services to hedge fund clients, including: financial accounting for equity, derivative, insurance linked securities, fixed income, and foreign exchange products; Net Asset Value (NAV) calculation and financial statement preparation; and investor record keeping and recording
- Manage and oversee the pricing of portfolios including equities, derivatives, insurance linked securities, fixed income and forwards, including FX trades and foreign currency hedging
- Oversee the production and review of SSAE 16 compliant daily, weekly and monthly files
- Manage and assist with client regulatory reporting requirements (i.e. Form PF, CPO-PQR, AIFMD)
- Plan and lead the preparation and review of audited financial statements and tax returns as required
- Support the reinsurance team to ensure seamless integration of middle office and NAV ops functions.
- Ensure that all client deliverables are on time and meet set quality standards
- Resolve and escalate issues/queries raised by the client in a timely manner and maintain a high level of client satisfaction and retention
- Manage, train and develop junior managers and other team members as assigned
