The Technical Officer (Insolvency) works under the direction of the Assistant Official Receiver, the post holder is responsible for processing 114A and 129A licence applications from local and exempted companies applying for licences to carry on business in Bermuda under the Companies Act 1981. Additionally, the post holder is responsible for processing permits pursuant to section 134 of the Companies Act 1981 and to sections 3 & 8 of the Overseas Partnership Act 1995 to carry on business in Bermuda. The post holder is also responsible for duties in connection with liquidations under the Companies Act 1981, the Companies Winding-Up Rules 1982 and Personal Bankruptcies pursuant to the Bankruptcy Act 1989. The post holder reviews applications for real estate broker and agent licences pursuant to the Real Estate Brokers' Licensing Act 2017. The post holder also undertakes other regulatory duties including processing applications by local and exempted companies seeking permission under section 120(4)(b) and 129(1)(a)(ii) of the Companies Act 1981 to provide accommodation or recreational facilities for its officers and employees.

Interested applicants must possess a Bachelor's Degree in Accounting, Law, Business Administration or equivalent, together with a minimum of three years' post qualification experience; which should include preparing comprehensive reports, memos and related correspondences. In addition, consideration may be given to applicants who do not meet the educational requirements of possessing a Bachelor's Degree in Accounting, Law, Business Administration or equivalent; but who possess six years' post qualification experience; which should include preparing comprehensive reports, memos and related correspondences.

COMMUNITY HEALTH NURSE

The Community Health Nurse works under the general supervision of a Health Visitor or Coordinator to provide community, school and clinic based nursing care. The post-holder works as part of a community health team to provide health maintenance, disease prevention, health promotion services, and undertakes administrative duties as required.

Applicants must possess a Bachelor of Science Degree in Nursing, be a Registered Nurse and have current CPR certification and possess registration or be eligible for registration with the Bermuda Nursing Council. A minimum of three years post qualification experience is also required. In lieu of a Bachelor of Science Degree in Nursing, consideration will be given to those applicants who possess six years' relevant experience.
