## SENIOR CROWN COUNSEL (SPECIALIST)

The Senior Crown Counsel (Specialist) works under the supervision of the Director of Public Prosecutions and in accordance with Section 71A of the Bermuda Constitution 1968, to conduct and manage the conduct of criminal hearings and prosecutions in Bermuda's Courts in respect to the Proceeds of Crime, Mutual Legal Assistance (including Extradition) and other related matters. The post holder conducts the full range of criminal proceedings in Bermuda's Courts and provides legal advice on criminal matters to the Bermuda Police Service and the Bermuda Public Service. In addition, the post holder is responsible for the professional development and training of the Crown Counsel and Crown Counsel (Junior Grade) under his/her supervision. The post holder also undertakes associated legal and operational duties within the Department of Public Prosecutions.

Applicants must have a minimum of eight years' post-qualification experience in criminal litigation, including experience as a prosecutor in a government environment with knowledge and experience in proceeds of crime, mutual legal assistance and extradition matters. In addition, they must be qualified as a Barrister and Attorney of a Commonwealth jurisdiction and must be a member of the Bermuda Bar Association or at least eligible to be a member.
