- Prepare analysis and commentary of our quarterly results for senior management
- Assist with acquisition accounting and integration activities where necessary
- Act as the key contact between Group Finance and other Finance functional groups within Sompo International to facilitate the combination of activities
- Assist with group budget and planning activity, where necessary
- Assist with the preparation of the Company's 401K Plan financial statements
- Oversee risk transfer review for assumed and ceded reinsurance contracts on a quarterly basis
- Other responsibilities and ad hoc projects as assigned (including process improvements and system upgrades)
