The Manager, Financial Planning and Analysis ("FP&A") will be responsible for the Validus Reinsurance ("Validus Re") FP&A process and will work closely with Group CFOs and the AIG Global FP&A team as part of the global AIG FP&A process.

KEY RESPONSIBILITIES:

- Work closely with Group CFOs in the preparation of corporate expense budgets for Validus Re and its subsidiaries;
- Develop and manage the intercompany recharge process with global finance teams, ensuring adherence to global transfer pricing rules and regulations;
- Act as a liaison between AIG FP&A and the Validus Group for all FP&A related matters, including expense analysis reports, capital model updates and budget systems implementations;
- Manage and oversee the Company's U.S. based accounting staff and perform the quarterly reviews of management accounts for the Company's U.S. subsidiaries;
- Prepare quarterly projections and forecasts and other ad-hoc reports as required, including submissions to Global FP&A leads;
- Develop and implement processes for the quarterly analysis of budget vs. actual results and work with business owners to provide detailed analysis and commentary to senior management on trends and variances;
- Prepare and analyze periodic financial plans and capital stress tests for Validus Re and its subsidiaries;
- Prepare the Validus Re BCAR and other analyst model comparisons with supplementary analysis;
- Improve on existing planning, forecasting and management information systems for key FP&A processes;
- Assist with the preparation of various rating agency surveys and submissions;
- Ad hoc requests and projects, as required.
