Trust Control Officer

The position reports to the Vice President, Trust Control. This position is responsible for performing annual reviews on fiduciary client base, ensuring completeness of administrative procedures and records. - Reviewing correspondence, trust and company records and safe custody files for compliance with
 the Trustees fiduciary responsibilities to ensure that the Trustees, through omission or error, is not
 exposed to any high level of risk as a result of its responsibilities to its fiduciary client base.
- Liaising with staff with regard to certain clients: to ensure that high risk cases are quickly brought to their attention and that the potential risks are fully understood.
- Referring complex issues of judgment, ethics or compliance to management.
- Any related duties as assigned by management.
