

Risk Officer

The Bermuda Monetary Authority is seeking the services of a qualified and experienced team member to work as a Risk Officer on our Enterprise Risk Management Team. Reporting to the Deputy Director, Enterprise Risk Management, the successful applicant will support both the execution of core day-to-day risk management activities, including overseeing the identification, measurement, monitoring and reporting risks, as well as the continued enhancement of the Authority's Enterprise Risk Management framework taken into consideration in key organisational planning and decision-making processes.

This role offers a unique opportunity to work in a dynamic and fast-paced setting and provides the successful incumbent with vast exposure across a broad set of topics and senior stakeholders across the Authority. The team is looking for an individual who enjoys an environment where autonomy and creativity go hand in hand with an ambitious and evolving activity portfolio. A person who is intrinsically motivated to complete and take personal ownership of attaining multiple deliverables within the same timeframe, creative, curious, a logical thinker with an open mindset, and enjoys collegiate consultation to find solutions to new and existing challenges would be well suited for this position.

This is a key role for the Authority and the post-holder will be responsible for but not limited to:

- Supporting the continued advancement of the Authority's enterprise risk management framework, including the implementation of risk management practices and tools
- Assisting in the continued identification of key risk areas within the Authority at enterprise and department-level, enhancement of identification and monitoring of key risk and control parameters, as well as identifying capabilities, gaps and needs
- Conducting horizon scanning to detect and assess potential threats to the Authority's operating model
- Participating in the development of appropriate risk response strategies in collaboration with stakeholders and leading designated internal risk working groups
- Leading the periodic preparation and delivery of risk reporting for assessing the evolution of the Authority's profile and assisting in decision-making processes
- Assisting in the continued monitoring and alignment of the Authority's strategic initiatives and operational processes with the Board-approved risk appetite and risk profile
- Supporting the ongoing improvements to the design, implementation and maintenance of a robust architecture for measuring risk exposure and control effectiveness, including the identification and reassessment of suitable risk and control metrics
- Fostering a sound risk culture and promoting risk awareness by providing support, education and training to staff on risk management and risk management issues
- Performing other related work and special projects as assigned by management in accordance with competencies normally associated with the post

This position requires a proven technical and business background. Therefore, the post-holder should have:

- A Bachelor's Degree or an equivalent in Risk Management, Finance or Business Studies or related subject area from a recognised or professional body
- A minimum of five (5) years' relevant post-graduate experience in the financial services industry and/or working experience with a financial regulatory body
- A professional qualification in risk management from an internationally recognised and accredited organisation is an asset
- Proven experience in the design and implementation of risk and control frameworks
