Job Summary

Reporting to the CTO, the Director of Outside Plant is a critical leadership role that oversees Outside Plant Services to provide highlevel quality control of the OSP departments (Maintenance, Construction, Service Delivery and Warehouse). The Director will oversee the department managers creating, implementing and enhancing consistent operational practices to ensure consistency with company initiatives and expectations. Direct responsibilities include performance management, purchasing, project planning, budgeting and business plan development. The key goal for this role is to actively and consistently support all efforts to simplify and enhance the customer experience.

Duties and Responsibilities

- Work Maintain and Support the Fiber Network and all outage restoration. Resolve all network outage and sustain our MTTR "Mean Time to Repair" to less than 4 hours
- Liaise with the Senior Manager of Engineering on Head End/Data Centre KPIs and how to address it in the field
- Set threshold/targets for HFC network performance and continue to drive results and continuous improvement of the network and staff
- Review and sign-off all invoices associated with the Section and assist CTO Planning & Service Delivery with controlling and monitoring of constructions expenditures, OT and other financial aspects of the department
- Prepare and annual capital and operational budget for the OSP section for review and approval. Receive and review bids for capital projects associated with department. Maintain and report on capital projects, operational expenses and provide OSP weekly updates
- Establish training and skills development curriculum for both new and existing employees; and ensure curriculum remains current and relevant. Participates in the hiring, training, and development of all departments under remit
- Manage both the productivity and quality of work down to the individual employee level; oversee and enforce workplace health and safety and provide safety training to employees as required
- Coach and mentor managers to increase and strengthen their professional development
- Manage the Network Performance with establish KPI and scorecards and hold the managers accountable to their respective areas

Skills and Abilities
