- Surveys, assesses and evaluates aircraft and records to recommend the issuance or suspension of Certificates of Airworthiness, Permits to Fly and Export Certificates
- Evaluates, assesses and approves organisations seeking approval under the provision of the Air Navigation (Overseas Territories) Order and the associated implementation of relevant airworthiness requirements
- Evaluates and approves Aircraft Manufacturing Organisations, Part 145 Aircraft Maintenance Organisations, Flight Lines and Private Individuals to ensure that established safety standards are implemented and maintained on Bermuda registered aircraft and approved organisations
- Reviews, evaluates and reports on Mandatory Occurrence Reports, Accidents and Incidents
- Reviews, evaluates and approves OTAR Part 145 Maintenance Organisation Exposition,

- MOE Supplement and OTAR Part 39 Maintenance Control Manual
- Provides assessment and examination of applicants seeking the issue, renewal, variation or revalidation of Part 66 Aircraft Maintenance Engineer's License
- Manages a portfolio of clients which entails effective support and regular communication

Interested candidates must possess an Aircraft Maintenance Engineer's License issued by EASA, FAA or TCCA or issued by a country acceptable to the employer.

The post requires a minimum of five (5) years relevant experience as a licensed Aircraft Maintenance Engineer, preferably including administration in a technical aviation or senior management role. This experience must include performing the duties and functions of an Airworthiness Inspector with an internationally recognised National Aviation Authority or a combination of similar experience acceptable to the employer.
