Coordinates and supervises the daily activities of the maintenance teams. Sets priorities for the teams to ensure task completion and coordinates work activities with other supervisors.

Decisions and problem-solving are guided by standards, policies, procedures, and business objectives; receives guidance and oversight from Maintenance Engineer and liaises crossfunctionally with other departments. Provides technical guidance to employees, colleagues and/or customers.

- Work cross-functionally to identify, prioritize, and deliver work to meet operational requirements and company objectives
- Ensure the accurate capture, collection, storage and compilation of field data and asset records to drive capital expenditure and operational improvements
- Identify and track core materials to ensure availability for future works, estimating requirements for consumables, working in conjunction with procurement
- Develop comprehensive work packages that effectively guide maintenance and refurbishment work
- Provide work packages, and liaise with, Foreman for daily/ weekly planning, scheduling and execution of work
- Ensure timely and effective inspection of structures and assets to drive operational improvements
- Be Authorized to SAP 2 Level
- Ensure Bermuda's and BELCO's health, safety and environmental rules and regulations are adhered to
- Determine if special tools, equipment, or services are required and ensure availability through quarterly audits
- Effectively manage and track personnel training competency to align with work requirements, inclusive of safety and environment
